SCHOLARSHIP AWARD REQUIREMENTS & INSTRUCTIONS

Please read carefully before completing the application.

REQUIREMENTS/ELIGIBILITY FOR CANDIDATES

The Candidate -

- 1) must be matriculated or matriculating into an accredited, degree-granting Masters or Doctor of Nursing Science or PhD in Nursing (with a research component) program for the 2025-2026 school year. There should be an emphasis on administration or management within the program and it must be at a School of Nursing within the United States.
- 2) must plan to continue in the field of nursing with a career interest in nursing administration, management, leadership, or education upon completion of degree program.
- 3) must be a Registered Nurse (RN) and a United States citizen.
- 4) must complete the Nursing Economic\$ Foundation Scholarship award application and submit to the Foundation office prior to the deadline of May 16, 2025.
- 5) may not have previously been awarded a Nursing Economic\$ Foundation Scholarship while enrolled in the same degree program for which this application is being made.
- 6) understands that this scholarship is not exclusive. It may be received by the student in addition to any other scholarships or grants that have been awarded.
- 7) grants the Nursing Economic\$ Foundation and the Nursing Economic\$ journal the right to publish a picture and biography or other application-related information if awarded a Foundation scholarship.
- 8) agrees that any scholarship awards will be used to defer the cost of tuition in the degree-granting program and further understands that the Nursing Economic\$ Foundation will pay the awarded scholarship jointly to the individual and the indicated school.
- 9) cannot be a member of the Nursing Economic\$ Foundation Board of Trustees; a member of the Nursing Economic\$ Editorial Board; an employee of the Nursing Economic\$ Foundation; an employee of Anthony J. Jannetti, Inc.; or a family member of any of the above.

APPLICATION INSTRUCTIONS

Please read all the instructions carefully before completing the Nursing Economic\$ Foundation 2025 Scholarship application. We suggest that you make a copy for your records of all sections of the application and supporting documentation except transcripts.

DEADLINES AND DECISIONS

May 16, 2025 is the deadline for the Foundation to receive your completed application. The Board of Trustees will review all completed applications after the May 16 deadline. Decisions will be made and scholarship winners notified by August 1, 2025.

It is your responsibility to ensure that we receive all sections of the completed application by May 16, 2025.

SPECIAL INSTRUCTIONS

Do not submit letters of recommendation or any other items not specifically required in the application. Such items will not be considered and will not be returned.

TUITION

You must submit the 2025-2026 tuition information for your degree program. If you are enrolled in a program that sets fees based on credit hours taken, please indicate the per credit fee and the total credit hours you will take in the 2025-2026 school year and calculate the total cost for the year. Documentation may be a photocopy of the tuition information printed in the course catalog or on the school website.

CURRICULUM VITAE

A complete curriculum vitae (C.V.) must be enclosed with this application. The items included in the C.V. should be: work experience, educational history, honors and awards, published works, presentations and lectures, and community service.

TEST INFORMATION

The Foundation requires submission of Graduate Record Examination (GRE) or Miller Analogies (Millers) test scores with this application. You must submit a photocopy of the official results or an original form from the testing service. Do not have the testing service send results directly to the Foundation office. The Foundation cannot accept responsibility for matching test scores to applications. *Test scores are required by the Foundation even if not required by your academic institution for admission. Only the GRE or Millers are accepted.*

NOTIFICATION

Notification will take place by August 1, 2025. Scholarship winners are notified initially by telephone weekdays between 8:00 am and 5:00 pm EDT. You may be contacted at your non-preferred telephone number in the event you have been awarded a scholarship. No scholarship money will be sent until telephone verification has been completed.

TRANSCRIPTS

You must submit an official transcript from each academic institution from which you hold a degree and from the program in which you are currently enrolled if any credits have been earned. The registrar should seal the transcript in an envelope and return it to you. Do not have the transcript mailed directly to the Foundation office. The Foundation cannot accept responsibility for matching transcripts to applications. All other forms of transcript submission are not acceptable.

- Curriculum vitae
